### SFAID - Processing your Aid

New for Fall 2020! For all Pell Grant eligible students who have met Satisfactory Academic Progress, completed their files, been awarded and enrolled in courses that begin at the start of term, the first 25% Pell Grant refund (scheduled the week prior to start of the term) is for books and supplies. The 2nd 25% refund for these courses would be scheduled after census (refer to chart below).

### Refund Dates - CCCD

Disbursement and refund dates are shown below for standard disbursement, summer disbursement, one semester only loans, and first-time loan borrowers. Dates are subject to change. Students are encouraged to complete their financial aid requirements early to ensure timely disbursement. While refunds through direct deposit may take about 48 hours to process, after disbursement, please be aware that check deliveries are dependent on distance and mailing service schedules/delays. Disbursement #1: 50% of the eligible loan funding will disburse approximately 3 weeks after the start of the first course. If you are a first-year, first-time loan borrower, disbursement will be approximately 5 weeks after the start of your first course.

### 2020-2021 Disbursement Schedule | Cal State LA

Financial aid generally begins disbursing one week prior to the first day of the quarter. To have your aid disbursed, you must have been awarded and have accepted your aid, not have any holds on your aid, if you are borrowing loans have completed required entrance counseling and signed promissory notes, and are registered for the minimum required credits.

### Disbursement | Student Financial Aid

Disbursement and Repayment. Disbursements to student accounts typically occur on the first day of each week. Any credit balance can be expected to be refunded within three (3) business days. Students who withdraw after the 60% Point are not required to return federal financial aid funds.
